- \$360,000 in grant applications were submitted, \$160,000 for chipping, \$100,000 for Logtown 10 and \$100,000 for Pollock Pines
- SRA grant money can be used for match on USFS grants

- Initial stage will have limited information that will be added to as project progresses

g. Input to the CAL FIRE AEU Fire Plan - Steve

 how does unit decide distribution, better way to calculate percentage, no requirement for
 grants to CCC go back to community of origin
