c. Senior Assistance - Ernie

- Have about 30 projects on the books two are being scheduled, several others scheduled for evaluation
- Need a clearer definition of relationship between FSC and FOS
- Suggestion for FSC and FOS to team up and submit joint grant proposal, possibly SRA grants that do not require match

d. Fuel Reduction Projects

i. Wentworth Springs - Mark

- Issue with getting right of entry,
- There is a possibility of extending scope of the project
- \$80,000 grant from PGE, project has to be completed by the end of September

iii. GF-12 Ernie

- CCC crew completed hand thinning, about 11 days worth, CCC came to them with offer of help which was greatly appreciated

v. Trestle Forest Health project, Teresa

- Went out for public comment on 17th, 45 day comment period
- Started as WUI fuel reduction project, extensive treatment proposed
- Have 3 alternatives now
- Has been 15-20 years since some areas have been treated
- Entire document is on Forest Service website
- Hope to start implementation this fall
- Have considered wildlife and watershed needs
- Grizzly Flats FSC is reviewing alternatives and will be presenting them to council on August 1st
- Hosting public meeting on July 31 to get comments to put into their comment letter
- Would like EDC FSC to send letter to Forest Service regarding Trestle Forest Health project and entire Grizzly Flats watershed is within that project
- GF will send a copy of their draft letter to EDC FSC to consider sending similar letter
