1.a Eastbound Hwy 50 to CA-49 North

* Turn left onto CA-49 / Coloma St. Continue to follow CA-49 North.

1.b Westbound Hwy 50 to CA-49 North

- * Turn right onto CA-49 / Coloma St. Continue to follow CA-49 North 7.7 mi.
- 2. Continue traveling on CA-49 North through Coloma (Marshal Park), Lotus and Pilot Hill

11.6 mi.

- **3. Turn right at Stop sign onto CA-193 / towards Georgetown & Greenwood.** Cool Village shopping center and Wells Fargo Bank on right.
- 4. Turn left onto American River Trail (Gate 1) and Check in at Guard Shack.
- 5. Continue short distance to first stop sign –at Westville Trail and turn left. Speed limit is 25 mph.
- 6. Continue to top of hill and eventual view of Golf Course, Pond, Swimming Pool and Lakeside Clubhouse on right. Continue on to #7.
- 7. Just past pool Turn right at Lakeside Golf & Racket Club <u>sign</u> at 2277 Westville Trail. Continue forwards towards parking area. "Lakeside Clubhouse" is left of pool area.
