5. Consent Agenda: 04/19/2023 Board Meeting Minutes Board Action Item

Item 11 Community Council Reports replace "what they can do for defensible space" with "what they did over the last year for defensible space". Minutes approved as presented with amendments.

6. New Business

- a. Elections Hugh Council
 Entire E-board is up for election for another year. The members of the board up for
 reelection are Brown, Willis, Kruse (not running Bob Hess is running in her place)
 Gilchrest, Zelinsky, Dwyer, Lory, Johnston, and Campbell. All board members will get a
 ballot via email prior to the election.
- b. Grants Coordinator Contract <u>Board Action Item</u>
 Pat Dwyer is officially done in the next couple months. It was recommended to hire
 Tamara Johnston and the E-Board made the decision to offer her a contract for this position. Tamara's contract was discussed with the board after she stepped out of the

room. The grants committee brought the idea to the board to hire a Grants Coordinator. We have reached a point where we need help with the grants process because of the amount of time it takes to work on the number of grants EDCFSC has at this time. The E-Board will amend the proposed changes and will reflect the Bylaws conflict of interest. Contract is approved with no opposition. Anticipated start date is June 1, 2023.

c. New Associate Fire Safe Council – Fort Jim <u>Board Action Item</u> Jason Jackson with Fort Jim FSC wants to tie in existing FSC's to get rid of some gaps between Diamond Springs Camino, Texas Hill and Pleasant Valley to make it more seamless. Fort Jim FSC approved with no opposition.

7. Old Business

- a. Defensible Space Training Update Hugh Council Finished two classes with a third class scheduled for June 2-3. There are roughly 75 people trained to do defensible space/home hardening evaluations. Will plan to do refresher classes sometime next year for those that completed the class. The evaluators can go outside your fsc boundary to do evaluations.
- b. Proposed Guideline and Criteria for Grant Applications Paul Penn 5.1 version deleted why, changed perspective from grants 2.0 to actual grants committee, added the abbreviations & pre-rfp phase. Use proposal as a working document as it is final for now. The grants committee should review annually and make changes as appropriate. This is meant to be a living document as guidelines that Tamara will use with FSC's for training and support.

8. Information Items

a. Chairman's Report & Communication

County is hosting a strategy workshop at EID at 1:30 pm today to get feedback from partners and stakeholders. The County is announcing the Program Manager for Office of Wildfire Preparedness & Resilience. This person should be starting the first week of June. County is interviewing for Senior Defensible Space Inspector, and they also partnered with CAL FIRE for defensible space effort this year. CAL FIRE put together target hazard areas. Information will be provided at OWPR website. Met with the County GIS and water agency for outward facing mapping tool. It's focused on fire prevention and fuels related data layers. Next phases will incorporate more heavy data. Tools will be in one place as grants are proposed.

b. Vice Chair Report

I will be at the EID meeting later today and I will also be getting things ready for June defensible space training. I will be at meetings for FPO's and Defensible Space Task Force.

c. Secretary Report

Reminder that councils' renewal forms are due as I only have 20 out of 30 councils right now. Board ballot paperwork is also due.

d. Treasurers Report: Janet Barentson Board Action Item

Auditor's opinion, (Vaughn Johnson) was presented. Everything is good no findings or recommendations found by auditor. It will be posted on website as soon as I get final copy from auditor. Our last audit was in 2012 so we are covered for the next 5 years. No changes from the previous month to the monthly Treasurer's Report. Treasurer's Report is approved as presented with no opposition. Proposed 2023-2024 budget for EDCFSC was presented. Budget is approved as presented. The accountant is on vacation, so I won't get checks until tomorrow. For those FSCs who have checking accounts under our EIN, I will send an email the first week of June for the process of reporting treasurer activity for accountant. This report will be due July 10th for the reporting period July 1, 2022-June 30, 2023.

e. Partners Reports:

1. BLM – Jason Schroeder

BLM is gearing up for fire season and the Folsom Lake Veterans group is coming next week. They are California's first veteran crew. Sheep grazing at Magnolia and Cronan Ranch. Burned 10 acres on Pine Hill last month with coordination from CALFIRE. BLM will help with administrative support for defensible space for homeowners. BLM asks that the FSC's approach us directly with a project to work through NEPA process to get clearance to do work. FSC's need to provide us with the project initiation and a map, and we will work with you through the NEPA process. BLM contacts are Jason Schroeder who is primary contact for FSC's, David Helgeson, and Jerry Martinez is the Zone Coordinator for Motherlode and Ukiah. Bureau of Reclamation will have a representative coming to meetings. Office of Wildfire Preparedness and Resilience submitted a \$10 million grant proposal to BLM to support defensible space and firewise community planning with priority given to lands adjacent to BLM.

The update will be brought to the Board of Supervisors in July for a first reading with a potential implementation date with changes to the ordinance for this fall. The County is also working to do defensible space inspections in the Kelsey, Coloma/Lotus, Outingdale and Texas Hill areas of the county this year. A reminder of the El Dorado County Fair June 15-18 joint display sponsored by the Forest Service, CAL FIRE, EDCFSC, RCD, the county and local fire districts.

August or September is a potential completed date. Operations are ongoing in the Pohoe Ridge Area for the Forest Service to sell logs from that project. Start operations back up in Pollock Pines and Camino area on forest service land starting May 29 and will continue until operations are complete.
